The Mississippi Gaming Commission held its regular monthly meeting at the Island View Casino in Gulfport, Mississippi, on Thursday, January 19, 2012 at 10:00 a.m. Commissioners John Hairston, Nolen Canon, and Jerry St. Pe were in attendance. Executive Director Allen Godfrey was also in attendance. The following matters were considered:

#### ADMINISTRATIVE UPDATE

Atronic Americas LLC changed its name to Spielo International USA, LLC effective October 28, 2011.

Multimedia Games, Inc. changed its name to Multimedia Games Holding Company, Inc. effective May 31, 2011.

MegaBingo, Inc. changed its name to Multimedia Games, Inc. effective May 31, 2011.
